Important Instructions

1. Only those candidates who fulfil the prescribed eligibility criteria and have been shortlisted for the Ph.D. admission process shall be permitted to appear in the interview.
2. Candidates are required to report at the venue **at least 30 minutes before the scheduled reporting time**.
3. Candidates must bring **original documents along with one set of self-attested photocopies** of all relevant certificates/documents, including:
 - o UGC-NET Certificate / Score Card;
 - o Proof of Date of Birth;
 - o Mark sheets and certificates of Bachelor's and Master's Degree;
 - o Category/PwD certificate, wherever applicable;
 - o Research Proposal/Synopsis, as prescribed;
 - o Any other document required for verification.
4. Candidates shall be required to appear for the interview **in person**. No request for change of the scheduled date/time shall ordinarily be entertained.
5. Mere appearance in the interview shall **not confer any right to admission**. Admission shall be subject to fulfilment of the prescribed eligibility criteria, performance in the interview, availability of seats and approval of the competent authority, as per the applicable rules/regulations.
6. Candidates are advised to regularly check the official notices of the College for any further information or changes relating to the Ph.D. admission process.
7. In case of any discrepancy or clarification regarding eligibility or documentation, candidates may contact the concerned office during working hours.
