#### An Overview:

The Library of the college is furnished as per the clause 15 of Schedule III of Legal Education Rules 2008 and fulfills more than Minimum Requirement.

The library is the 'heart' of any academic institution and plays an important role in all academic activities and, the more so, in law institutions. There is Ground+4 floors Library building as Central Excellence Wing in college campus. Ground Floor is complete Library- Book Zone with the office of Librarian and 1st floor is equipped with Reading Hall and Electronic Library.

The library has been planned keeping in view the aims and objectives of the Law College, and is being operated by a team of professionally qualified library staff. The entire library is being operated through MARC21 Koha Software (online issuance and return). It has a collection of over 19,324 volumes only law books covering a wide range of general and special subjects, comprising of text books, reference books, back volumes of journals and reports etc., apart from current legal periodicals. The Library functions from 8.30 a.m till midnight on all working days of the week.

The Law College has introduced facility known as Electronic Library for both housekeeping as well as information retrieval. Since it now has a high speed Broad Band line connection to the internet as well as subscription of Lexis Advance -an online facility of Law Journals, AIR, Supreme Court's Judgments, High Courts Judgments, Subordinate Courts Judgments and any matter of law (Online & Offline **both**) it is possible to have easy access to information directly from all available computerized data bases all over the world, not only in the field of law but also in other disciplines.

With a computerized library system it is the aim of the library to establish a network of law libraries in India and also to establish a National Legal Information Centre, which will act as a clearing house of information in the field of law.

The Library has all state-of-the-art gadgets with Wi-Fi internet connection and highly modernized Audio-Visual equipments with tele-conferencing facility as well as ILMS Koha Software Cloud.

The library has introduced computerized facilities for both housekeeping as well as information retrieval. Since we have now a broad band width leased line connection to the internet it is possible to have easy access to information directly from all available computerized data bases all over the world, not only in the field of law but also in other disciplines. Keeping in mind the vision to create an E.Law College, the University subscribes to many international online databases.

- The college management has instituted several exemplary academic management practices.
- The College Governing and Departmental Staff Committee is vested with the authority to make crucial decisions regarding academic matters.
- Non-teaching staff enjoy positive working conditions and offer unwavering support for administrative functions.
- Faculty members are actively encouraged to pursue research, attend seminars, and organize workshops and conferences.
- The library is fully computerized and offers comprehensive access to e-resources such as Manupatra, Lexis-Nexis Advance, and SCC Online, for both faculty and students.
- The E-library, under the supervision of late Barrister S.K. Sahay, is regulated and operated according to the guidelines of IQAC.
- Internet and Wi-Fi facilities are seamlessly available across the entire campus.
- The college operates with a structured academic calendar that ensures orderly implementation of activities.

#### 3. Academic Practices

- The majority of faculty members employ highly effective and diverse teaching methods.
- The college is equipped with ICT-enabled classrooms, fully integrated with network and Wi-Fi connectivity.

- A variety of committees and mentors are appointed to each class to monitor attendance, provide remedial coaching, conduct class tests and internal exams, and oversee syllabus completion, students' activities, and participation.
- An Academic Term Plan is in place, encompassing a wide range of activities aligned with the prescribed curriculum's curricular and extracurricular components.
- New entrants undergo a thorough evaluation to assess their strengths and weaknesses through the "Students' Analyzer Program."
- Remedial courses are offered to students who require additional support.

#### 4. Infrastructure and Financial Support for Academic Activities

- The college boasts outstanding infrastructural facilities, including well-maintained buildings, a state-of-the-art library, reading halls, special exam rooms, NAAC and NSS cells, a Moot Court Hall, ICT-enabled classrooms, an administrative block, a canteen, and a healthcare center.
- The computer lab offers free access to students and faculty, promoting hands-on learning and research.
- Well-maintained common rooms are available for both boys and girls.
- Faculty and students are actively encouraged to engage in research and academic activities through a variety of supportive programs.

#### 5. Institutional Social Responsibility (ISR)

- The college has a robust and dedicated NSS unit that organizes community-oriented activities such as tree plantation drives, jail visits, court visits, and free health check-up camps.
- Legal aid programs, blood donation camps, and cleanliness drives are conducted regularly, while socio-legal awareness is promoted through legal aid camps, street plays, and law lectures delivered by faculty members.
- The Women's Cell, managed by senior faculty members, provides a platform for female students to discuss and resolve any concerns. The cell is easily accessible, ensuring timely intervention in case of issues.
- An Anti-Ragging Cell, established in compliance with UGC guidelines, is available for students to report any incidents anonymously, if needed.
- The Student Grievance Cell ensures the redressal of any complaints related to dignity, safety, student-teacher relationships, and gender-related issues.

• The College Internal Complaint Cell (ICC) is established under regulatory guidelines to address grievances and ensure a safe, inclusive, and supportive environment for students, faculty, and staff. The ICC is committed to upholding principles of fairness, transparency, and confidentiality in handling complaints.

#### 6. Functioning of IQAC

- The IQAC operates in strict adherence to NAAC guidelines, ensuring quality assurance across all academic processes.
- It prepares comprehensive academic term plans and action plans to guide various activities conducted within the college.
- The IQAC diligently monitors the teaching-learning process by coordinating with faculty members.
- Students' feedback forms are analyzed rigorously, with necessary follow-ups to ensure continuous improvement.
- Strengthens alumni participation in institutional development by involving them in mentorship programs, guest lectures, and feedback mechanisms.
- The IQAC organizes awareness programs, and conducts workshops, seminars, and sensitization programs to educate stakeholders about quality assurance, accreditation standards, and institutional objectives.
- The IQAC conducts periodic reviews of its action plans, ensuring that goals are met efficiently.

#### **Overall Analysis**

#### **Observations on Key Aspects**

#### 1. Institutional Strengths

- Excellent infrastructure that supports both academic and extracurricular activities.
- A highly experienced and dedicated faculty that drives the institution's success.
- A well-equipped computer lab and library, including a dedicated reading hall, fostering a strong academic environment.
- The College Development Committee holds significant authority in making pivotal academic decisions.

#### 2. Weaknesses

- Limited placement opportunities and job prospects for graduates.
- Lack of sufficient technical support staff for virtual and technology-based activities.
- A significant number of students come from economically disadvantaged backgrounds and Schedule Tribes Community, posing challenges for academic performance due to their financial status and linguistic barriers respectively.

#### 3. Challenges

- Instilling professional ethics and a positive attitude in students.
- Striving to provide practical, hands-on education that complements theoretical knowledge.
- It is very challenging to open and run the 5 years courses.

#### 4. Opportunities

- Expanding collaborative programs and strengthening college-industry linkages.
- Securing additional financial support from UGC and other funding agencies to improve infrastructure and resources.
- Increasing the frequency of workshops and faculty development programs (FDPs) to train faculty in ICT usage, online teaching tools, and modern pedagogical methods.

#### 5. Recommendations

#### Vital Recommendations

• The college should urgently hire technical support staff to address ongoing ICT challenges.

#### Essential Recommendations

- Encourage peer learning among students to enhance collaborative and interactive learning.
- While faculty have begun integrating ICT tools into teaching, they require further technical support to resolve issues effectively.
- Infrastructure should be enhanced to facilitate the development and delivery of e-learning materials, including the construction of a dedicated studio room.
- The college faces a shortage of hostel facilities for outstation students. This challenge can be mitigated by securing funding from UGC/government or revising the fee structure.

#### Desirable Recommendations

- The internal evaluation process should be restructured to ensure more objectivity.
- Faculty members should receive greater financial support for research initiatives.
- It is essential to provide high-quality plagiarism detection software for postgraduate students, in line with UGC guidelines.

#### **Roles and Duties**

#### (As per observations and recommendations)

#### 1. State Government

• Revising the fee structure for aided and unaided courses is necessary to improve training facilities and infrastructure.

#### 2. College

#### a. Management

- Increase the number of permanent staff positions to ensure sustained academic growth.
- Provide technical support staff to address the increasing need for virtual and technologybased support.
- Initiate MoUs with other top-ranking academic institutions and industries for mutual collaboration and enhanced placement opportunities.
- Consider publishing an Annual News Bulletin to keep the community informed of achievements and developments.

#### b. Academia

- Faculty should make optimal use of the internet and teaching aids to enhance the learning experience.
- Organize more invited lectures on contemporary issues such as IPR, Research Methodology, etc., and encourage faculty to present their expertise at external institutes.
- Encourage faculty membership in professional bodies to keep them informed about industry trends and developments.
- Organize two or three international conferences annually, along with seminars on emerging interdisciplinary issues.

#### c. Students

- Although students are generally satisfied with classroom and practical teaching, there should be a concerted effort to help them secure higher ranks in university examinations.
- Increase student participation in NSS, sports, and cultural activities to foster a well-rounded educational experience.
- Provide additional e-learning modules in the Central Library's dedicated reading room for students' convenience.

#### d. Other Stakeholders

- Involve alumni more actively in the college's development, tapping into their expertise and experiences.
- Organize more parent meetings to keep them informed about their children's academic progress.
- Strengthen linkages with industry partners for internships, faculty visits, and the development of tailor-made courses suited to industrial needs.

- The college has been accredited in its second cycle by NAAC, demonstrating its continuous efforts toward quality enhancement.
- With its focus on academic excellence and a strong vision, the college has the potential to be a model institution for legal education.
- The college should work diligently to implement the above recommendations to continue its upward trajectory in academic and infrastructural development.
