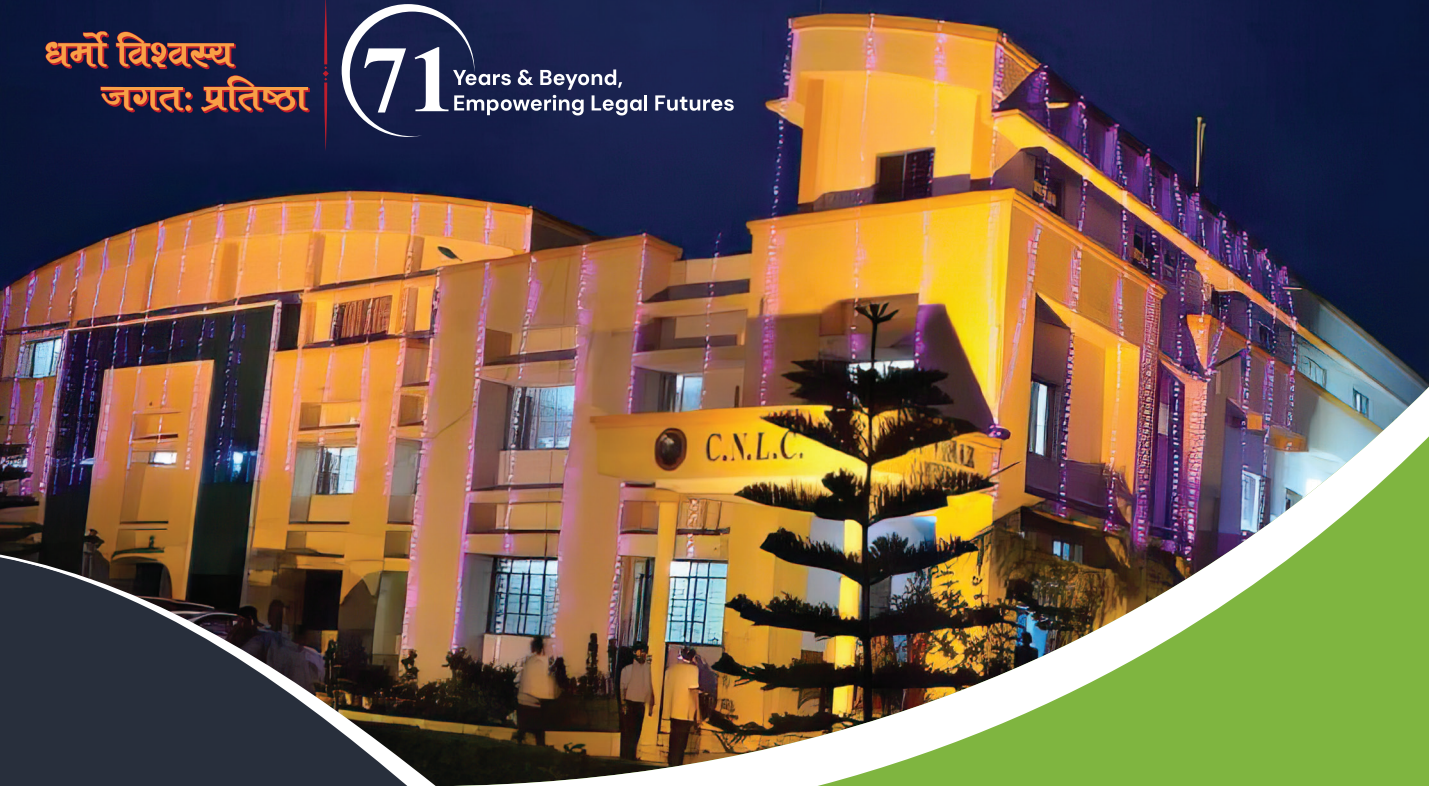

Eligibility for admission and pattern of selection

Candidates who have graduated from a recognized university or hold academic qualifications deemed equivalent to a graduate degree in any discipline, with a minimum of 45% marks in their bachelor's degree, are eligible to appear for the Entrance Test for admission to LL.B. Part-I. Final-year bachelor's degree students may also apply. Merit-Based Selection : Admissions will be granted based on merit, determined through performance in the Entrance Test. Deserving candidates, irrespective of background, are selected fairly and transparently.

Mode of Entrance Test : **Offline mode.**

Medium of Entrance Test : Hindi and English Medium (Both).

Question Booklet of Entrance Test will be Hindi and English medium.

How to apply for CNLET (LL.B.)

The entire application process is conducted online. Candidates seeking admission to the 3 years LL.B. Degree program, can apply through the official college website (www.cnlawcollege.ac.in). They must complete the application form, upload the required documents, and submit it after making the necessary online payment for the Admission Form Fee, including the Entrance Test Fee.

Syllabus of CNLET (LL.B.)

*Objective Questions: General Knowledge, Current Affairs, Legal aptitude, Abbreviations	60 marks
**Subjective Questions: Essay on legal topics, Drafting a letter	40 marks

***Purpose of Objective Questions in CNLET (LL.B)**

Importance in Legal Studies

A strong foundation in General Knowledge and Current Affairs reflects a candidate's awareness of national and international developments, which is fundamental for understanding evolving legal frameworks. Additionally, Legal Aptitude assesses the ability to think critically and apply analytical reasoning to legal scenarios, an essential skill for a successful legal career.

Evaluation of Key Competencies

Objective questions play a crucial role in measuring critical thinking by testing a candidate's ability to assess situations and make informed decisions. Legal Aptitude exercises further refine analytical skills by challenging candidates to interpret complex information, recognize patterns, and reach logical conclusions.

Ensuring Fairness and Standardization

Multiple-choice questions provide a standardized and impartial evaluation process, minimizing bias and ensuring consistency in assessment. This format also facilitates an accurate comparison of candidates' competencies, offering a fair and transparent means to measure legal aptitude and knowledge.

Through objective questions covering General Knowledge, Current Affairs, and Legal Aptitude, CNLC's LL.B entrance examination seeks to holistically evaluate candidates' intellectual preparedness and potential for success in legal education.

****Purpose of Subjective Questions in CNLET (LL.B)**

Developing Critical Thinking and Expression

Essay-based questions demand an in-depth exploration of complex legal topics, requiring candidates to think deeply and present structured, well-reasoned arguments. Similarly, drafting letters assesses the ability to communicate effectively, ensuring clarity, conciseness, and professionalism in legal writing.

Assessing Legal Knowledge and Practical Application

Essays serve as a tool for examining a candidate's comprehension of legal theories, principles, and doctrines. Additionally, letter drafting evaluates the practical application of legal knowledge by challenging candidates to construct legally sound documents.

Enhancing Communication and Writing Proficiency

Candidates are tested on their ability to present complex ideas clearly and coherently through essays and legal drafts. These tasks also assess the ability to organize thoughts logically, ensuring structured and persuasive communication.

Building Essential Legal Skills

Legal writing and drafting form the backbone of a successful legal career, where articulate and precise communication is paramount. Moreover, these exercises foster analytical thinking by encouraging candidates to critically assess legal scenarios and formulate well-founded arguments.

By incorporating subjective questions focused on legal essays and letter drafting, CNLC aims to equip candidates with the necessary skills for excelling in law and broader legal profession.

Reservation Policy:

The Sankalp issued by Jharkhand State Government vide memo no.-14/आर.मी.-04-02 / 2019 का.1434 Ranchi dated 15.02.2019 (enclosed) for implementation of reservation in admission of students is hereby notified and adopted by Ranchi University, Ranchi vide memo no.RU/DSW/83/2019 dated 12.06.2019.

Category	Reservation Percentage
Schedule Caste (SC)	10%
Schedule Tribe (ST)	26%
Other Backward Class (BC-I & II)	8 + 6 = 14%
Economically Backward Class (EBC)	10%

Note: As per the Sankalp issued by the Jharkhand State Government, female candidates appearing for the entrance examination will be given a 5% weightage on their scored marks as part of the selection criteria.

Scholarship :

Eligible candidates may avail scholarships under the E-Kalyan Scheme, administered by the Welfare Department of the Government of Jharkhand , subject to specified criteria by the department from time to time.
