

CONCEPT NOTE

Jharkhand, endowed with rich natural resources, cultural heritage, and youthful demographic strength, must align its developmental trajectory with the larger national vision.

Public policy education plays a crucial role in this endeavor by equipping stakeholders with the knowledge, analytical tools, and leadership skills required to shape effective governance.

RATIONALE FOR THE WORKSHOP

India's vision for a developed nation—Viksit Bharat by 2047—demands a robust ecosystem of knowledge, leadership, and governance rooted in constitutional values and responsive public policy. Jharkhand, with its rich cultural heritage, tribal wisdom, and strategic resources, stands at a pivotal juncture where inclusive development must be driven by empowered institutions and informed citizens.

This workshop seeks to catalyze capacity-building in public policy education as a transformative tool for regional and national progress. By integrating interdisciplinary curriculum design, leadership development, and evidence-based governance, the initiative aims to:

- Equip academic institutions, civil servants, and youth with policy literacy and civic competence
- Foster participatory governance through localized and context-sensitive policy frameworks
- Align Jharkhand's developmental priorities with the national agenda of Viksit Bharat
- Promote simulation-based learning, bilingual documentation, and statutory compliance in policy pedagogy

The workshop will convene thought leaders, educators, policymakers, and students to co-create actionable strategies for embedding public policy education into Jharkhand's academic and administrative landscape. It will also showcase best practices, institutional models, and curricular innovations that can be scaled across India.





THEME, SUB-THEMES & ISSUES FOR CRITICAL THINKING & DISCUSSION

The theme reflects a timely and transformative vision for India's development journey. Public policy education brings together different subjects to solve social problems, encourage new ideas, and prepare future leaders. Starting a School of Public Policy in Jharkhand will improve the state's education system and help create policies that support tribal welfare, sustainable development, better governance, and digital progress. This will help both Jharkhand and India move closer to their development goals. The workshop aims to initiate this journey by bringing together thought leaders to co-create a roadmap that supports Vikshit Jharkhand and contributes meaningfully to Vikshit Bharat.

SUB-THEMES

 - Addressing governance gaps in mining, forest, and land management
 - Policy frameworks for sustainable livelihoods and environmental justice
 - Iharkhand's experience with CSR, displacement, and rehabilitation policies
- 3. Youth, Academia, and Civic Engagement in Jharkhand's Policy Ecosystem (झारखंड की नीति प्रणाली में युवा, अकादिमक एवं नागरिक सहभागिता)
 - Role of universities and law colleges in shaping public policy discourse
 - Engaging youth in simulation exercises, policy labs, and civic innovation
 - Promoting constitutional literacy and democratic values in tribal and rural belts

OBJECTIVES OF THE WORKSHOP

- The workshop aims to initiate a comprehensive dialogue on the establishment of School of Public Policy in Jharkhand, emphasizing its necessity and contextual relevance within the state's sociopolitical landscape.
- A key focus will be on understanding best practices adopted by leading Public Policy schools across India and globally, thereby informing the strategic development of Ranchi University's proposed School of Public Policy.
- The workshop also intends to examine ways to align public policy education with Jharkhand's development priorities, including tribal welfare, sustainable development, governance reforms, and policy-driven innovation.





GUIDELINES FOR PAPER SUBMISSIONS

- 1. The Paper should range from 5000-8000 Words.
- 2. Footnotes should be in Bluebook 20th Edition.
- 3. The themes are broadly suggestive. The author may write on any topic relevant to the theme of the Workshop.
- 4. Submissions should be in:
 - a. Times New Roman, 12 font size with 1.5 line spacing, justified text, and 1-inch margins on all sides of an A4 sheet.
 - b. Footnotes should be in Times New Roman, 10-font size with 1.0 line spacing.
 - c. Endnotes and/or Bibliography and in-text citations are not allowed.
 - d. Headings should follow the following standard.
 - i. Title of the submission: Upper-case, bold, font size 14
 - ii. Headings: Upper-case, bold, font size 14
 - iii. Sub-Headings: Title-case, bold, font size 12
 - iv. Sub-Sub-Heading: Title-case, italics, font size 12
 - v. The submission must be the original work of the author and must not have been submitted elsewhere or pending review.
 - vi. Co-authorship up to a limit of two is allowed.
- 5. Authors are instructed to use footnotes only.
- 6. The manuscript should be accompanied with the author's name, designation, name of institute, contact number and e-mail for future reference and correspondence.
- 7. Avoid AI-generated content; all submissions must be original work by the authors. Authors are responsible for ensuring that the content submitted for publication is primarily the result of human effort, with AI-generated content limited to a maximum of 10%.





- 8. All the contributions should be the original work of the contributors. All submissions will undergo the plagiarism test. Plagiarism must not exceed 10%. If plagiarism exceeds this threshold, papers would be rejected.
- Submissions should prioritize clarity and simplicity in language, avoiding unnecessary jargon or overly complex sentences. Ensure factual accuracy and compliance with relevant laws and regulations.
- 10. Note that the manuscript submitted by the author should not be submitted or presented at any seminar. The manuscript submitted for publication should not undergo any additional publication process or review process, and it should not be shared within any organization or institution.

Note: The selected manuscript will be published in the form of a book with International Standard Book Number (ISBN)
