SUBMISSION GUIDELINES

1. Abstract Submission:

- Abstract of not more than **500 words** with **3-5 keywords**.
- Abstracts should provide a clear outline of the topic, research questions, and objectives.
- Early submissions will be given priority in the review process.

2. Manuscript Submission:

- Articles must be original, unpublished, and not under consideration elsewhere.
- Manuscripts should be in **Times New Roman**, font size **12**, with **1.5-line spacing**.
- Use the **Bluebook (latest)** footnoting style for citations.
- Footnotes should be in **Times New Roman**, font size **10**, with **single line spacing**.

- Manuscripts should be divided into clear sub-parts for readability.
- Charts, graphs, and illustrations (if any) should be original and submitted separately in high resolution.
- **File format:** Word Document (.doc or .docx)

- The subject line should mention: “**Submission for Volume 17 – [Your Name]**”.
- Kindly mention in the manuscript:
 - Author’s full name, designation, and institution.
 - Contact details and email ID.
 - Include Plagiarism Report (Manuscript with plagiarism exceeding **10%** will be rejected.)
