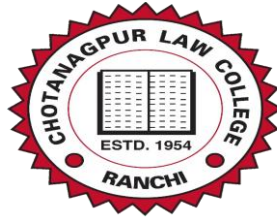

## SUBMISSION GUIDELINES

### 1. Manuscript Submission:

- Articles must be original, unpublished, and not under consideration elsewhere and should consist of an abstract (NOT MORE THAN 350 words) with 3-5 keywords.
- Abstracts should provide a clear outline of the topic, research questions, and objectives.
- Manuscripts should be in Times New Roman, font size 12, with 1.5 line spacing.
- Use the Journal of Indian Law Institute [\(JIL\)](#) footnoting style for citations.
- Footnotes should be in Times New Roman, font size 10, with single line spacing.
- Manuscripts should be divided into clear sub-parts for readability.
- Charts, graphs, and illustrations (if any) should be original and submitted separately in high resolution.
- File format: Word Document (.doc or .docx)

## **SUBMISSION PROCEDURE**

- Please submit your manuscripts with abstracts via [cnlclawreview@gmail.com](mailto:cnlclawreview@gmail.com).
- The subject line should mention: "Submission for Volume XV – [Your Name]".
- Kindly attach a cover letter with the submission, mentioning:
  - Author's full name, designation, and institution.
  - Contact details and email ID.
  - Include Plagiarism Report (Plagiarism exceeding 10% will be rejected.)
